Corporate and commercial law

For one of the world leading suppliers of tools, machined tools and modern materials used in manufacturing processes, we completed historically first Czech-German cross-border merger. In relation with this merger, we simultaneously established a subsidiary of a foreign legal entity. Also, we are providing this client with complete contractual documentation, including employment documents.

For daughter companies belonging to the holding company dealing mostly with supplying and installation of heating systems, cooling systems, ventilation, medical technique, industrial gases, sprinklers, MaR, including the project documentation related, we carried out the restructuring, particularly through the merger.
